- 1. They have better avenues to advertise for considerably less money
- 2. Better promos that aren't single use
- Outreach has not met good faith effort standards and it's too much money for single use items
- 4. I am a part of a small student org and listservs are very effective for advertising
- 5. Suggest material alternatives, such as social media and monitors around campus
- 6. Unsustainable materials don't seem to fit in our mission as the SSC
- 7. The items requested for funding produce unnecessary single use waste and seem unnecessary for promoting the event since social media and digital advertisements are just as effective and free
- 8. I don't believe this event will, in the long run, do much to promote sustainability at UK
- They should use the resources they have available first before asking for money to purchase single use promotionals
- 10. Promotional materials proposed seem physically wasteful (single use paper materials) that need to be printed too soon to be useful... This event is about 2 weeks away
- 11. I don't think this program is a worthwhile use of funding. Their organization should fund this, not the SSC
- 12. It's single use plastic and they can use other platforms to promote (screens at the Student Center and JSB, social media, etc)
- 13. Unsustainable marketing materials

- 14. Suggest free options and sustainable options (student org copier, electronic billboards, social media)
- 15. Small event like this doesn't need this large of an outreach budget- especially since the event is so soon
- 16. Would generate unnecessary waste and other advertising/marketing sources could be better utilized (social media, screens, flyers, etc)
- 17. Many other resources available if only marketing is required
  - **h.** 8:10 Discussion of DOPE Conference begins
    - i. Did they start advertising their speakers before they got funding
      - Often with conferences, you have to contact speakers really far in advance, so that is a common practice
    - ii. In their proposal, we did not see any documentation of their past funding from the SSC
      - 1. That is due to technical formatting issues
    - iii. I find it surprising that they do not charge a single fee for UK students- a20 dollar fee would not be too far out of reach for UK students
      - 1. It could also allow for more funding for outside students
    - iv. It is confusing that they do not structure their conference to be applicable for outside funding
    - v. This is a really good conference and a long time partnership with the SSC
    - vi. This is the most money that they have ever asked for
      - The longevity is in question, because a first year conference asked the same amount as a 10th year conference- is that fair

**Describe how your project relates to the three pillars of sustainability (environmental stewardship, economic equity, and social inclusion).:** Co-Sponsorship with the Office of Undergraduate Research, we hope to continue support for summer fellowships in undergraduate research related to sustainability. Students working together with faculty mentors proves a vested interest in knowledge generated from their research. This continues the SSC's support to institutionalize sustainability in various forms at the University of Kentucky, while the three pillars of sustainability are met depending on each individual student selected and their choice of research.

Please provide an in depth description of your project. You will likely want to copy and paste your response into the text box.: The Office of Undergraduate Research is eager to continue our co-sponsorship of summer undergraduate research fellowships and the Intercollegiate Sustainability Research Experience (ISRE) opportunities as they relate to sustainability. Last year, the Council awarded the Office of Undergraduate Research \$16,500 to support 6 UG summer sustainability fellowships that included a newer part of the Summer Sustainability Research program - The Intercollegiate Sustainability Research Experience (ISRE). The part of the summer program was formatted from the NSF's National Research Experience for Undergraduates (REU) model. Three of six students received a \$2500 award to work on their research projects, while three students spent their summer at other universities working with UK Alumni faculty. All of these junior faculty are UK alumni graduates. One student, Jessalyn Robey, went to LSU and worked under the direction of Dr. Jerrod Penn. The second student, Kaci Hurks, worked with Dr. Katelyn Kesheimer at Auburn University, and the third student, Caroline Morkel, went to UC Riverside and worked with Dr. Mehdi Namati. The ISRE has been extremely successful as noted below by both faculty and student statements: Caroline Morkel stated "This experience has contributed to my education because it has made me pursue a master's in public policy and working under Dr. Nemati. Possibly continuing to a PhD program in economics to study environmental economics. Dr. Mehdi Nemati was a great mentor for the summer. He was very accommodating and gave me a lot

of guidance in what to do. Information that I will take from this is how to work in an office setting with post doc students, how to conduct research, and how to write research documents. Dr. Nemati was very helpful. Overall, I had a great summer and thoroughly enjoyed working under Dr. Nemati. I am very grateful for this opportunity." We have secured 4 faculty from last summer and a new faculty from New Mexico State University "is on board" to participate this coming summer. Another new initiative that began last year was a collaboration effort with the UK Food Connection who sponsored one student stipend. Maria Sanchez was chosen for this fellowship. Maria spent the summer working with Dr. Kelly Davidson at the University of Delaware. Dr. Davidson stated "Maria is wonderful! Our data collection is off to a successful start. She has really taken the lead on participant recruitment and time management. I'm highly impressed, and we are thankful to have her." In Maria's year-end report she stated "My mentor, Dr. Kelly Davidson, provided feedback that gave me the confidence to push the boundaries of my work and offered essential professional and educational advice about post-graduate education. She was open-minded about new methods that I suggested and made me feel like an essential member of the team. I would not have grown as a researcher had it not been for her. To improve my summer research experience, I think I would've liked to have arrived earlier, simply because I enjoyed the work I did so much and wish I would've had more time to help recruit more participants for the study. Overall, this has been the best experience of my undergraduate career and I am so thankful for it." Because of this successful experience between the faculty mentor and student, the UK Food Connection agreed to continue their collaboration efforts to support one student as part of the ISRE for summer 2020. In fact, the Food Connection has already provided the summer funding to the Office of Undergraduate Research. These experiences are providing enriching, high impact opportunities for our students! The "wheels are in motion" to increase faculty as we are in communication with the Tracy Farmer Institute to identify even more faculty to this program with the hope that we can extend opportunities outside of Agriculture. We are very eager to increase the overall award amount to award one more student for the summer of 2020. Proposal Outline: 1) Request funding amount of \$20,000. 2) Three to four of the six awardees will receive a stipend of \$2500 funded by the SSC. They will conduct research with a UK mentor. This is the same process as in previous years. 3) The additional four to five awardees will participate in the ISRE part of the program. These students will apply for a position with a faculty mentor at a different university. We have secured commitments from 5 faculty alumni for the summer of 2020. This program was a huge success this past summer, as supported by the positive comments provided by both faculty and students. We will continue to seek Dr. Jerrod Penn's help to identify new faculty partners who are interested in joining the ISRE program. These faculty may or may not be UK faculty alumni. The Office of Undergraduate Research has reached out to the Tracy Farmer Institute to gain information from their faculty database to help identify new faculty alumni, as well. These conversations are ongoing. Each student will be expected to move to the mentor's university for the summer for no less than 8 weeks. In return, the awardee will receive a stipend equal to \$4500, \$2500 from the SSC and the remaining \$2000 from the outside mentor. This equates to a 60% / 40% funding split in the cost of intercollegiate summer fellows and this number reflects the in-kind efforts of the non-UK faculty. 4) \$2000 (\$500 each) would be used to subsidize the travel/living expenses of the four – six students participating in the ISRE part of the program. 5) The Student Sustainability Council (SSC) selects the student award recipients. The Office of Undergraduate Research administers and coordinates

funding per student as well as a formal process for selecting eager, high-quality students to be submitted to the SSC and the ISRE. This type of research practice creates enhanced opportunities for UK students via a more challenging experience for undergraduates to travel outside their home university. The ISRE opportunity provides a 'more impressive' experience to demonstrate with potential employers and a more attractive summer stipend by leveraging additional funds from the sponsoring faculty.
